Note: Permit only good for 45 days and no permit will be extended past 60 days. Road Superintendent requires a 24 hour notice to the Township before starting. A drain pipe of reinforced concrete or corrugated steel of at least 10 inch diameter must be installed beneath the driveway and extend 4 feet on both sides of the driveway, unless otherwise approved by American Township Board of Trustees. Numbers 7 & 8 below do not pertain to curbed driveways. NO PLASTIC PIPE.

If this permit is granted, I/we agree to the following conditions.

1. That the restoration of the road frontage shall be equal to its original state.
2. That traffic will be maintained at all times, unless permission is granted by the Township Trustees/Road Superintendent to do otherwise.
3. That the necessary lights, signs, barricades, flagmen and watchmen are maintained for the protection of traffic at all times, day and night, during the work provided for under this permit. Permit holder assumes all responsibility to provide said safety devices in excess of those recommended by Road Superintendent when needed.
4. Spoil dirt from the construction site must not be placed in any ditch or roadside swale.
5. If the roadway pavement is damaged either by construction, construction equipment or by excess weight I/we will make complete restoration as advised by the American Township Trustees and Road Superintendent.
6. That in all construction in American Township flex pipe cannot be used in the right-of-way of any street or road.
7. That the driveway pipe must be installed coincident with the construction of the driveway. The driveway pipe must be properly bedded as shown in the standard drawing to prevent crushing by heavily loaded construction vehicles.
8. That the bond will not be returned to the applicant until the driveway meets the specifications set forth by the American Township Trustees in the Minimum Drainage and Driveway Standards drawing. The size and type of driveway pipe specified by the Township must be installed before the bond can be released.
9. If the 45-day period between the date given on the permit and the completion of the work is not met, the applicant will forfeit the said bond. In some circumstances a 15-day extension can be given on permits. After permit expires the application must be re-filed with the American Township Administration Office with the standard fee.
10. No construction or job site material such as dumpsters, stone, wood, building material, etc. may be stored on any township road or right-of-way.
11. If at any time the driveway location is moved a new application must be submitted to the American Township.
12. Surface of driveway apron abutting the roadway must be level or below the surface of the roadway.
13. Driveways can be no wider than 40'.
